**TERMS AND CONDITIONS OF MEDICAL OFFICER ON JOB CONTRACT BASIS**

The terms & conditions of job contract for Medical Officer shall be as under :-

- (i) Consolidated remuneration of Rs.20,000/-per month will be paid to the candidates having qualification of MBBS and Rs. 26,000/-per month to the Post Graduation Degree / Diploma holders. There will be no dearness/ vehicle/ compensatory allowance admissible/ payable during the period of contract.
- (ii) He/She will be entitled to causal leave for 13 days in a calendar year as per rules.
- (iii) He/She will not be entitled to any advance like House Building, Motor Cycle/Car Advance etc. and also not be entitled for other fringe benefits such as free electricity, LTC & EL during contract period.
- (iv) He/She will be entitled for TA/DA and accommodation charges for journey performed by him in the Company's interest as admissible to Class-I Officers of the MPSEB/MPPGCL.
- (v) The facility of unfurnished accommodation would be provided on payment of rent limited to Rs.1,000/- per month.
- (vi) The CUG mobile phone facility with the ceiling of Rs.200/- per month shall be admissible. The instrument shall be arranged by the user.
- (vii) During outstation official visits, a vehicle shall be made available to him whenever possible. In absence of this facility, taxi charges shall be paid to him, as per applicable rules.
- (viii) Medical facilities as available in MPSEB's Hospital will be provided to him free of charges.
- (ix) His/Her head quarter will be at Power Houses of MPPGCL and he/she shall work under the administrative control of respective head of the Power Station.
